CRESS, Don. Translator. Jean-Jacques Rousseau: The Basic Political Writings. Introduction by Peter Gay. Indianapolis: Hackett Publishing Co. 1987.

This volume contains: Discourse on the Sciences and the Arts; Discourse on the Origins of Inequality; Discourse on Political Economy; On the Social Contract. The same year appeared a separate edition of On the Social Contract, translated by D. Cress and with the introduction by Peter Gay. Also by Hackett Publishing Company.

DASENBROCK, Reed Way. Redrawing the Lines: Analytic Philosophy, deconstruction, and Literary Theory. Minneapolis, MN: University of Minnesota Press, 1989.

"Redrawing the Lines brings together ten essays by key figures who have worked to connect literary theory and philosophy and to reassess the relationship between analytic and Continental philosophy. The editor's introduction established the debate's historical context, and his annotated bibliography directs the interested reader to virtually everything written on this issue."
